General guidance for candidates

General guidance

This is a formal assessment that you will be marked and graded on. You will be marked on the quality and accuracy of your practical performance and the written work you produce. It is therefore important that you carry your work out to the highest standard you can. How well you know and understand the subject, and how you have used your knowledge and skills together to complete the tasks must be clear to the marker. This means you will have to explain your thinking and the reasons behind the way you have carried out the tasks are how/why you have made your decisions within your written work eg as part of your planning, reflections, or evaluations.

Plagiarism

This is an assessment of your abilities, so the work must be all your own wirk and carried out under the conditions stated. You will be asked to sign a declaration that you have not had any help with the assessment.

Your tutor is allowed to give you some help understanding the assument instructions if necessary, but they will record any other guidance you need and his will be taken into account during marking.

Plagiarism is the failure to acknowledge sources properly and/or the submission of another person's work as if it were your own. Plagiarism is not allowed in this assignment.

Where research is allowed, your tutor must be able to identify which work you have done yourself, and what you have found from other sources. It is therefore important to make sure you acknowledge all sources and clearly reference any information taken from them.

Timings and planning

Where you have to plan your time, you should take care to make sure you have divided the time available between tasks appropriately. In some assignments, there are specified timings which cannot be changed and which need to be taken into account. You should check your plan is appropriate with your tutor.

If you have a good reason for needing more time, you will need to explain the reasons to your tutor and agree new deadline date. Changes to dates will be at the discretion of the tutor, and they not mark work that is handed in after the agreed deadlines.

Written work eg reports may be word processed or hand written unless stated otherwise.



Assignment Brief

You work for a building surveying company that has been commissioned to advise on a building project for a commercial business which specialises in making furniture for the education sector.

The existing building has a 1930s structure and with a fabric of solid brick walls and plaster on the inside surface. The original windows, covering a very large area above the main entrance façade have been replaced with double-glazed uPVC units. The existing building floors are oal bands and are in good condition, except for some surface discolouration. The Mace material is slate and has been maintained over the years. The building is served by gas, electricity, water supply and drainage. The main boiler of the building is and is around 10 years old.

The client is keen to evaluate the following two options:

- Demolish the existing building and construct new portal frame premises in its place
- Refurbish and extend the existing building

Both options are feasible, but a number of technical challenges, in various stages of the project, will have to be analysed before a final decision can be made.

The client will only make a final decision when a full range of construction project constraints have been considered fully. As a local employer and neighbour to other businesses and


residents nearby, the company is also very keen to re-launch itself with this project on the basis of it being positive for the community, the environment (sustainability is important to the owner) and the company's financial future.








Steel portal frame construction near completion

- Construction contract procurement arrangements for both options.

Task 3

Specify a steel portal frame to provide the necessary flexible space in the proposed development and draw its main structural components.

- a) Carry out an appropriate structural analysis for determining the steel portal frame main column and rafter sizes.
- b) Describe the mechanical plant and equipment used to lift and assemble the proposed steel portal frame structure.
- c) Draw an annotated CAD detail of a portal frame connection joint, to an appropriate scale.

Conditions of assessment:

- You may take your research materials into the assessment

 You may use a scientification.

- You will have access to a computer with internet and any uitable CAD software to complete Task 3.

What you must produce for marking:

- A written report including:
 - Structural analysis for the steel portal frame column and rafter selection.
 - The necessary civil engineering technology (mechanical plant and equipment) for the lifting and assembly of a portal frame structure to suit this project brief.
- A PDF file of your CAD detail portal frame connection joint.

Additional evidence of your performance that must be captured for marking:

None for this task.

Task 4

- a) Draw a super-installed external wall vertical section, to an appropriate scale, using manual drawing equipment and processes.
- section through an opening in the external wall, to an appropriate AD. Any element of the opening can be detailed.

Top ditions of assessment:

You must carry out Task 4 on your own, under supervised conditions.

You will have access to manual drawing equipment to complete part a) and a computer with internet and any suitable CAD software to complete part b).

What you must produce for marking:

- For Part a) a clear, detailed scan of your manual drawing, with appropriate contrast, showing the super-insulated external wall section.
- For part b) a PDF file of your scale CAD drawing, showing a detailed section through an opening in the external wall.

Additional evidence of your performance that must be captured for marking:

Task 5

Specify a suitable drainage system necessary to meet modern commercial building requirements. This must include:

- The building services facilities that must be connected to an efficient and effective drainage system.
- Typical pipe diameters for various building services facilities.
- Essential pipework gradients for building services facilities.

Resources

Candidates must have access to a suitable range of resources to carry out the tasks and, where appropriate, to have the opportunity to choose materials demonstrating the ability to select from a range of appropriate materials. Resources specific to the tasks are as follows:

- Candidates should be given access to a computer with internet access during the assessment.
- Candidates should be given access to a scientific calculator for Tasks 2 and 2.
- Where a drawing element is required for a task, either manual or using CAO shiware as detailed in the task specific guidance, the centre must supply the candidate with the following:
 - Manual drawing equipment which typically includes a drawing part with a T-square, set squares (60/30 and 45), a scale ruler, appropriately sized drawing paper (e.g. A3 and A4) and a pencil. The drawings must be gone over using a drawing pen to allow the work to be visible when scanned into the Moderation Portal (additional time may be allowed to do this).
 - Access to a computer with any suitable CAD software, e.g. AutoCAD or SketchUp, Adobe Acrobat and access to a printer.

Task 1

The certification of the candidates with access to technical references on:

duilding survey reports of existing buildings

Property/facilities management roles for commercial buildings

 Options for contract management, procurement, forms of contract and managing of contracts.

The above could comprise Building Regulations Approved Documents, trade or manufacturers literature to illustrate case study examples and textbooks on building structure and fabric and building services.

Task 2

The centre must give candidates access to IT equipment that has presentation software (e.g. Microsoft PowerPoint).

The centre must give candidates access to technical resources include building regulations Approved Document F (Ventilation), magazine articles to illustrate natural and mechanical ventilation case study examples and textbooks on ventilation in various types of buildings and various spaces (rooms) within one building.

The centre may also wish to give candidates access to the following information:

- An explanation of how fan sizes are selected for various mechanical ventilations.

- ventilated according to air pressure variations due to the wind effect effect
- How mechanical ventilation is essential in buildings to ensure the efficient removal of excess heat and (humidity) moisture

Task 3

Task 3 has a structural steel portal frame focus but incur structural analysis, mechanical plant and equipment and a drawing detail.

For part a), centres should give candidates access to the various Eurocodes/British Standards/Standard structural formulae and manufacturers standard section tables for rafters and columns.

For part b), candidates should refer to the green mechanical plant used to lift structural steel portal frame components into position safe assembly.

For part c), candidates must be given access to CAD drawing software in order to produce a detail of a portal frame connection joint. The drawing is to be to an appropriate scale for printing.

Task 4

For Part (a) centre must give candidates access to suitable manual drawing equipment to draw an external wall vertical section that is super-insulated. For part b) candidates must have sees to suitable CAD drawing software to produce the detailed section through an in the external wall. The detail can be through the head, sill or jamb.

Candidates must also be given access to relevant technical information on super-insulated external walls from building regulations Approved Documents, magazine articles to illustrate case study examples and textbooks on building structure and fabric.

Centre guidance

Guidance provided in this document supports the administration of this assignment. The following documents, available on the City & Guilds website, provide essential generic guidance for centres delivering Technical qualifications and **must** be referred to alongside this guidance:

- Technical qualifications marking
- **Technical qualifications moderation** (updated annually)
- Technical qualifications teaching, learning and assessment

This synoptic assessment is designed to require the candidate to make use of their knowledge, understanding and skills they have built up over the course of their leaving to tackle problems/tasks/challenges.

This approach to assessment emphasises to candidates the importance and applicability of the full range of their learning to practice in their industry area, and supports them in learning to take responsibility for transferring their knowledge, understanding and skills to the practical situation, fostering independence, autonomy and confidence.

Candidates are provided with an assignment brief. They then have to draw on their knowledge and skills and independently select the correct processes, skills, materials, and approaches to take to provide the evidence specified by the brief.

During the learning programme, it is expected that tuto will have taken the opportunity to set shorter, formative tasks that allow candidates to be supported to independently use the learning they have so far covered, drawing this together in a similar way, so they are familiar with the format, conditions and expectations of the synoptic assessment.

Candidates should be made aware during learning what the Assessment Objectives are and how they are implemented in marking the assignment, so they will understand the level of performance that will achieve them high marks.

Candidates should not be entered for the assessment until the end of the course of learning for the qualification so they are position to complete the assignment successfully.

Health and safety

Candidates should not be entered for assessment without being clear of the importance of working safely, and practice of doing so. The tutor must immediately stop an assessment if a candidate work, to safely. At the discretion of the tutor, depending on the severity of the incident, the sandidate may be given a warning. If they continue to work unsafely however, their assessment must be ended and they must retake the assessment at a later date.

Compliance with timings

time, not any additional setting up the centre needs to carry out to create an appropriate assessment environment.

It is the centre's responsibility to plan sufficient assessment sessions, under the appropriate conditions, within the assignment window, to allow candidates reasonable time to complete the assessment tasks.

Where candidates are required to plan their work they should have their plans confirmed for appropriateness in relation to the time allocated for each task.

Candidates should be allowed sufficient time to fully demonstrate the range of their skills. however this also needs to be reasonable and practicable. Candidates should be allowed to overrun their planned timings or professional service times (where they exist) in order for evidence of a range of their skills to be captured. If however, the time required exceeds reasonably set assessment periods, or the tolerance suggested for professional service times, the centre may stop the assessment and base the marking on the evidence up to that point, including the tutor's notes of how far over time the task has taken.

notes must be recorded on the practical observation (PO) form provided. The centre has flexibility to adapt the form, to suit local requirements (eg to use tablet, hand-written for to ease local administration) as long as this does not observed.

The number of candidates a tutor will be able to observe at one time will vary

- the complexity of evidence collection for the task
- local conditions eg layout of the assessment environment.
- amount of additional support available (eg to capture image) video evidence), staggered starts etc.
- whether there are any peak times where there is a love evidence to collect that will need additional support or any that are quieter.

It is advisable to trial the planned arrangements where pessible during formative assessment, reviewing the quality of evidence caretured and manageability. It is expected that for straight forward observations, (and unless otherwise specified) no more than eight candidates will be observed by a single tutor and the number will usually be fewer than this maximum. The key factor to consider is the logistics of collecting sufficient evidence.

As far as possible, candidates should be distracted, or their performance affected by the process of observation and evidence collection.

Observation notes form part of the candidate's evidence and must describe how well the activity has been carried out ather than stating the steps/ actions the candidate has taken. The notes must be very test riptive and focus on the **quality** of the performance in such a way that comparison between performances can be made. They must provide sufficient, appropriate evidence that can be used by the marker (and moderator) to mark the performance using the marking grid.

Identifying what is about the performances that is different between candidates can clarify the charities that are important to record. Each candidate is likely to carry out the same stops so a checklist of this information would not help differentiate between them. How qualitative comments on how well they do it, and quantitative records of accuracy and plerances would.

The tutor should refer to the marking grid to ensure appropriate aspects of performance are recorded. These notes will be used for marking and moderation purposes and so must be detailed, accurate and differentiating.

Tutors should ensure that any required additional supporting evidence including eq photographs or video can be easily matched to the correct candidate, are clear, well-lit and showing the areas of particular interest in sufficient detail and clarity for assessment (ie taken at appropriate points in production, showing accuracy of measurements where appropriate).

If candidates are required to work as a team, each candidate's contribution must be noted separately. The tutor may intervene if any individual candidate's contribution is unclear or to ensure fair access (see below).

The **Technical qualifications guides on marking and moderation** are essential guidance documents and are available on the City & Guilds website. These provide further information on preparing for assessment, evidence gathering, standardisation, marking and moderation, SMEN and must be referred to when planning and carrying out assessment.

Minimum evidence requirements for marking and moderation

The sections in the assignment:

- What you must produce for marking, and
- Additional evidence of your performance that must be captured for many

list the minimum requirements of evidence to be submitted for marking and the Cod sample.

Evidence produced during assessment above and beyond this may be supplied èd, as long as it provides useful information for marking and moderation and has been produced under appropriate conditions.

While technological methods which support the capturing or creating of evidence can be helpful, eg pinboard style websites for creating mood boards, the jinal evidence must be converted to a suitable format for marking and moderation which cannot be lost/ deleted or amended after the end of the assessment period (eg screen prints, pdf files). Considerations around tracking authenticity and potential loss of material loss of materi assessment is the centre's responsibility.

Where candidates have carried out some work as agroup, the contribution of each candidate must be clear. It is not appropriate to submit identical information for each candidate without some way for the marker and moderator to mark the candidates individually.

Note: Combining candidates' individual dieces of evidence into single files or zip files may make evidence management during internal marking more efficient and will greatly simplify the uploading of the moderation ample.

Where the minimum requirements have **not been submitted** for the moderation sample by the final moderation deathir o, or the quality of evidence is insufficient to make a judgement, the moderation, and therefore any subsequent adjustment, will be based on the evidence that has been submitted. Where this is insufficient to provide a mark on moderation, a mark of zero may be given.

should be aware of which aspects of their performance (across the AOs) will give then good marks in assessment. This is best carried out through routinely pointing out good r poor performance during the learning period, and through formative assessment.

During the learning programme, direct tutor instruction in how to tackle practical tasks through modelling, support, guidance and feedback are critical. However gradual removal of this support is necessary in preparation for summative assessment. This, supported approach is **not** valid for summative assessment.

The purpose of summative assessment is to confirm the standard the candidate has reached as a result of participating in the learning process. Candidates should be encouraged to do the best they can and be made aware of the difference between these summative assessments and any formative assessments they have been subject to. Candidates may not have access to the full marking grids, as these may be misinterpreted as pass, merit distinction descriptors. Refer to the *Technical qualifications – teaching, learning and assessment* centre guidance document, available on the City & Guilds website for further information on preparing candidates for Technical qualification assessment.

Guidance on assessment conditions

The assessment conditions that are in place for this synoptic assignment are to:

- ensure the rigour of the assessment process
- provide fairness for candidates
- give confidence in the outcome.

They can be thought of as the rules that ensure that all candidates who take an essessment are being treated fairly, equally and in a manner that ensures their result reflects their true ability.

The conditions outlined below relate to this summative synoptic assignment. These do not affect any formative assessment work that takes place, although it is advised that candidates are prepared for the conditions they will need to work under during summative assessment.

The evidence for the tasks that make up this synoptic assignment must be completed under the specified conditions. This is to ensure authenticity and prevent malpractice as well as to assess and record candidate performance for assessment in the practical tasks. Any aspect that may be undertaken in unsupervised conditions is specified. It is the centre's responsibility to ensure that local administration and oversight gives the tutor sufficient confidence to be able to confirm the authenticity of the candidate's work.

Security and authentication of candidate work

Candidate evidence must be kept secure to prevent unsupervised access by the candidate or others. Where evidence is produced over a number of sessions, the tutor must ensure learners and others cannot access the evidence without supervision. This might include storing written work or artefacts in acked cupboards and collecting memory sticks of evidence produced electronically at the end of each session.

Candidates are required to sen declarations of authenticity, as is the tutor. The relevant form is included in this assignment pack and must be signed after the production of all evidence.

Where the candidate or tutor is unable to, or does not confirm authenticity through signing the departation form, the work will not be accepted at moderation and a mark of zero will be given. If any question of authenticity arises eg at moderation, the centre may be contacted for justification of authentication.

ccessibility and fairness

Where a candidate has special requirements, tutors should refer to the *Access* arrangements and reasonable adjustments section of the City & Guilds website.

Tutors can support access where necessary by providing clarification to **any** candidate on the requirements or timings of any aspect of this synoptic assignment. Tutors should **not** provide more guidance than the candidate needs as this may impact on the candidate's grade, see the guidance and feedback section below.

All candidates must be provided with an environment, time frame and resources that allows them reasonable access to the full range of marks available.

Where candidates have worked in groups to complete one or more tasks for this synoptic assessment, the tutor must ensure that no candidate is disadvantaged as a result of the performance of any other team member. If a team member is distracting or preventing another team member from fully demonstrating their skills or knowledge, the tutor must intervene.

Guidance and feedback

To support centre file management, tutors may specify a suitable file format and referencing format for evidence (unless otherwise specified eg if file naming is an assessment point for the assignment). Guidance must only support access to the assignment and must not provide feedback for improvement. The level and frequency of clarification & guidance be

- recorded fully on the candidate record form (CRF),
- taken into account along with the candidate's final evidence during making
- made available for moderation.

Tutors **must not** provide feedback on the quality of the performance or how the quality of evidence can be improved. This would be classed as malpractice.

Tutors **should** however provide general reminders to candidates hroughout the assessment period to check their work thoroughly before submitting it, and to be sure that they are happy with their final evidence as it may not be worked on further after submission.

Candidates can rework any evidence that has been preduced for this synoptic assignment during the time allowed. However, this must be as a result of their own review and identification of weaknesses and not as a result of futor feedback. Once the evidence has been submitted for assessment, no further an examents to evidence can be made.

Tutors **should** check and be aware of the candidates' plans and designs to ensure management of time and resources is appropriate, and so any allowed intervention can take place at an appropriate time.

Tutors **should** ensure that candidates' plans for completion of the tasks distribute the time available appropriately and may guide candidates on where they should be up to at any point in a general way. Any excessive time taken for any task should be recorded and should be taken into account during marking if appropriate.

It is up to the marker to decide if the guidance the candidate has required suggests they are lacking in any A. The severity of the issue, and how to award marks on the basis of this full range of evidence. The marker must record where and how guidance has had an impact on the marks given so this is available should queries arise at moderation or appeal.

What and is not, an appropriate level of guidance

A tutor **should intervene with caution** if a candidate has taken a course of action that will result in them not being able to submit the full range of evidence for assessment. However, this should **only** take place once the tutor has prompted the candidate to check that they have covered all the requirements. Where the tutor has to be explicit as to what the issue is, this is likely to demonstrate a lack of understanding on the part of the candidate rather than a simple error, and full details should be recorded on the CRF.

• The tutor **should not** provide guidance if the candidate is thought to be able to correct the issue without it, and a prompt would suffice. In other words, only the minimum support the candidate actually needs should be given, since the more tutor

- guidance provided, the less of the candidate's own performance is being demonstrated and therefore the larger the impact on the marks awarded.
- A tutor must not provide guidance that the candidate's work is not at the required standard or how to improve their work. In this way, candidates are given the chance to identify and correct any errors on their own, providing valid evidence of knowledge and skills that will be credited during marking.
- The tutor must not produce any templates, pro-formas, work logs etc unless
 instructed to in the assignment guidance. Where instructed to do so, these materials
 must be produced as specified and contain no additional guidance. Templates
 provided as part of the assignment should be used as provided, and not adapted

All specific prompts and details of the nature of any further guidance must be recorded on the relevant form and reviewed during marking and moderation.

Guidance on marking

Please refer to the **Technical qualifications** – **marking**, and - **moderation** centre guidance documents for further information on gathering evidence suitable for marking and moderation, and on using the marking grid and forms.

The candidate record form (CRF) is used to record:

- Details of any guidance or the level of prompting the candidate has received during the assessment period
- Rough notes bringing together relevant evidence from across tasks during marking.
- Summary justifications when holistically coming to an overall judgement of the mark.

The practical observation form (PO) is used to record:

Descriptive information and everage of candidate performance during an observation. Although descriptions of the quality of performance should support decisions against the AOs the notes should follow the flow of the observation, rather than attempting to assign evidence against the AOs at this point.
