Recommended Browsers

CloudShare is compatible with all modern browsers that support HTML5.

List of supported browsers:

- Internet Explorer 9 or above.
- Chrome 4 or above.
- Firefox 3.5 or above.
- Opera 10.5 or above.
- Safari 4 or above.

CloudShare has a Remote Access Test imbedded which validates whether a browser supports Canvas and Secure Web Sockets. You can find more information about these in this article.


- Note: the article also discusses port requirements (which are related to the network vs. the browser itself).
- ➤ There is a possibility your firewall may stop the Secure Web Socket which would be needed to run CloudShare. You may need to liaise with your IT department to amend the firewall settings.

Speed Test
