This is a qualification that our members would consider if they were employing someone as a:

- Herdsperson
- Shepherd
- Dairyman
- Livestock contractor
- Assistant poultry unit manager

The qualification covers the relevant skills and knowledge required to enter into the type of job roles above, and these could include

- Health and safety in a farming environment
- Operate machinery (tractor driving)
- Business skills
- Grassland management
- Farm animal health and nutrition
- Dairy production
- · Beef production
- Pig production



- Poultry production
- Sheep production
- Farm animal science
- Pollution control and waste management
- Maintenance and repair skills e.g. for gates and fencing
- All Terrain vehicles and tele-handlers

## City & Guilds Level 3 Advanced Technical Extended Diploma in Agriculture (Arable) (1080)

This is a qualification that our members would consider if they were employing someone as a:

- Contractor (arable)
- · Assistant head tractor driver
- Fixed plant manager
