The employer

The Guilds Engineering Company is a land-based machinery dealership providing sales, maintenance and repair services for the land-based sector.

You are a technician who specialises in farming machinery and equipment, and you work with the following staff:

The customer

The project

The company service manager has asked you to research the requirements of the service plans for the five different types of land-based machinery and equipment that City Farm offers, produce service plans for two of the types of machinery or equipment, and a timetable of work for City Farm's machinery or equipment which will cover the next two years. You are asked to research and develop a proposal for the service work which will be reviewed by the service manager.

You must consider the financial impacts of the service plans and make sure there is minimal impact on the day-to-day work of City Farm. All machines are well maintained with full service records.
