The Employer-Set Project will assess content from across both the common core content and the Animal Management and Animal Science core pathways content.

## **Section A**

### The employer

The Guilds Animal Sanctuary is an animal sanctuary that is open to the public and keeps a range of different animals including:

- large and small mammals
- birds.

The sanctuary employs a number of staff who are responsible for the care of the animals and the running and upkeep of the sanctuary.

Figure 1 shows the current site layout of the Guilds Animal Sanctuary.

### The project

Your employer has carried out a review of waste management at the sanctuary and found that the consumable waste generated from operations on the sanctuary is poorly managed and does not comply with its Waste Management Strategy, which is based on the 5Rs of waste management - refuse, reduce, reuse, repurpose, recycle.

You are working as a junior manager at the Guilds Animal Sanctuary, and you have been asked to improve the sanctuary's approach to waste management, to ensure it complies with its Waste Management Strategy.

You will do this by:

- Developing a waste management solution conduct research and produce a report recommending your solution.
- Planning how your recommended waste management solution could be implemented – produce an implementation plan for your solution.

Your role is to consider the types of consumable waste generated from the operations at the sanctuary and how they are currently managed, determine what improvements can be made, and plan how these changes will be implemented.

You will gather feedback and will have the opportunity to recommend further changes and improvements.


The sanctuary has a budget of up to £18,000 per year for waste management.

You will be required to use the information provided in the brief, and undertake your own research, to come up with a waste management solution and an implementation plan.

### The Guilds Animal Sanctuary: Current roles and responsibilities of staff/contractors

Role	Responsibilities	Number of staff
General manager	Oversees all operations of the sanctuary.	1
Junior manager	Implementation of waste management proposal, training of staff, auditing of processes to comply with Waste Management Strategy, liaising with facilities management.	2
Facilities management	Maintenance of the yards and buildings on the sanctuary. Contribute to the implementation of the waste management solution (facilitate moving/placing skips/waste containers on site).	2
General staff	Feeding and care of animals and facilities, responsible for following waste management procedures including correct management/disposal of waste, in line with the sanctuary's Waste Management Strategy, attending training and upskilling as directed by the junior manager.	8
Volunteers	Assisting the general staff with tasks as directed, attending training as directed by the junior manager.	4
Waste contractor	Provision of skips/containers and collection of waste from agreed location/s on site.	N/A

The Guilds Animal Sanctuary keeps the following animals:

The feeding and care of the animals generates the following consumable waste. All animal byproduct waste is non-clinical.

Waste is poorly managed and does not comply with the Waste Management Strategy, due to the following issues:

#### **Issues identified**

All types of consumable waste generated by the sanctuary are currently disposed of together in a single skip with no consideration for the 5Rs of waste management. Current practice is not fully compliant with The Waste (England and Wales) Regulations 2011.

Consumable waste collection is managed through a contract with Super Skips. Super Skips provides one skip for all consumable waste. (The current location of this skip is shown on the site layout).

General staff feed the animals but do not clean the tins before being disposed of.

Tins and carboard boxes are not being flattened by the staff.

The area around the skip is often untidy with loose waste, encouraging vermin.


All types of consumable waste are being moved unsecured across the site to the skip, resulting in litter in the grounds.

Volunteers do not always attend work regularly.
