OVERVIEW

What does this qualification cover?

This qualification covers a very wide range of areas related to the skills and knowledge required for working in the Equine industry.

All learners will cover the mandatory core units of:

Receive a horse and carry out an initial assessment
Plan diets and implement feeding regimes for horses
Promote the health and well-being of horses
Monitor and maintain stocks of feed and bedding
Deliver basic health care treatment to horses
Promote, monitor, and maintain health, safety and security of the workplace
Manage your own resources

You can then take optional units that are relevant to the chosen pathway of interest:

- Horse care and management
- Horse care and riding
- Breeding
- Coaching

The very wide choice of optional units will reflect the work environment that you are in, and the type of role that you are carrying out.

This is a Framework qualification.

• Who could take this qualification? OR who is this qualification designed for?

This qualification is part of the Apprenticeship in Horse Care and Management or it may be taken as a stand alone qualification.









It is a work-related, competence-based qualification, and is designed for someone in work or who wishes to progress into work. It reflects the skills and knowledge needed to do a job effectively, and shows that you are competent in the area of work the qualification represents.

The qualification may allow you to combine working for an Equine business, such as a Riding School, Competition Yard, Equestrian Centre, Private Yard, or Stud or a similar job, and typically involves you attending one day a week at College or with a Training Provider.

There are no specific prior achievements required to take this qualification, but a Level 2 or another Level 3 qualification in Horse Care or other Land-based related subjects could be an advantage.

You need to be 16 years old or over to take this qualification.

This qualification could lead to jobs such as:

- Trek Leader
- Intermediate Instructor/Level 3 coach
