Summer 2024 results release information for T Level Technical Qualifications

Hi Centre,

As we approach the results day next week for the T Level Technical Qualifications, we're sharing some important information and guidance with you in advance to help you prepare.

Please read this update carefully, paying particular attention to the embargo of student results.

Embargoed T Level results

T Level providers can view student component results for T Level Technical Qualification Core (examinations and Employer-Set Project) and Occupational Specialisms from 08:00 on **Wednesday 14 August 2024.**

These results are embargoed and must not be shared with students until 08:00 on Thursday 15 August 2024.

IMPORTANT

Results are **EMBARGOED** and must not be shared with students until 08:00 on Thursday 15 August 2024.

Please familiarise yourself with our T Level registrations, assessment entries and results guide. It provides step-by-step instructions on how to access and download the T Level Result Slips from Walled Garden.



It is important that you don't use existing reports in Walled Garden (such as candidate history, results listing or certification listing) to view results for T Levels as they will not provide sufficient level of detail.

Our grading guidance provides detailed information on the grading and awarding process for T Levels, as well as Uniform Mark Scale (UMS) and rules regarding re-takes. The guidance is available on our <u>T Levels Resource Hub</u> or via the link below.

Letter to students from Ofqual and UCAS

Core Reports and Occupational Specialism Reports

Core Reports and Occupational Specialism Reports for each T Level Technical Qualification will be available on their qualification page from Thursday 15 August 2024.

These provide support and guidance to aid the delivery of the learning and assessment for the Core assessments or Occupational Specialism assessments. They also include the grade (and notional) boundaries for the summer 2024 assessments.

Accessing student scripts and marks

For T Levels, City & Guilds provides copies of examination scripts, as part of the core assessments for each series.

For the core exams, we provide a copy of the student's exam script including a summary sheet with the mark achieved per question, and the total mark for the assessment.

For the Employer-Set Project, a summary sheet is provided with a breakdown of the task marks and the total mark for the assessment.

We're introducing a new way to access this service. Access to student scripts (including the ESP mark summary) will be available in Walled Garden from **Thursday 29 August**.

We've updated the guidance in the Registrations, Assessment Entries and Results Guide. Please familiarise yourself with the new approach

Please note - access to scripts will no longer be provided via the T Level Service Portal.
