## SASE Apprenticeship Frameworks at Intermediate (Level 2) and Advanced (Level 3) – CITB statement

The Construction Industry Training Board (CITB), in its role as the Issuing Authority for Construction Apprenticeships developed under the Specification of Apprenticeship Standards England (SASE), has taken the **decision not to proceed with the planned closure of a number of Apprenticeship frameworks at the end of July 2019**. This has been done in response to information received from the Institute of Apprenticeships and Technical Education (IFATE) about the readiness of some end point assessment organisations to deliver certain construction related Apprenticeship Standards.

CITB's primary concerns in taking this decision are to ensure that individual candidates are not disadvantaged and that the end-point assessments delivered ensure a quality outcome for learners and industry.

**The table on the next pages provides a summary of the previous plans for the closure of frameworks, and any changes to this position.**

CITB will continue to work closely with IFATE, employer trailblazer groups, training and end-point assessment organisations to agree a timeline for the closure of each framework as new standards are approved for delivery.

In line with our previous commitments, we will ensure that providers are given at least 6 months notice of any planned closures.

The Education and Skills Funding Agency has stated that all frameworks (where they have not already been closed by Issuing Authorities) will be withdrawn by them 2020 to 2021 academic year, as they expect that employers and providers will have completed the transition by this date. ## Update on City & Guilds apprenticeship standards

City & Guilds are committed to offering the construction trailblazers and the update below gives the details on the status of each trade, the assessment plan status and a guideline of timescales for delivery.

### **Bricklayer 9077-12**

We are approved as an EPAO to offer this standard.

The assessment plan is still undergoing amendments and we do not have a date when this will be finalised yet. There is an assessment plan currently on the IfA website which is showing as a final assessment plan, but this will be replaced later this year once the new assessment plan is approved. Once we receive confirmation of this we will communicate detailed timescales for when first registrations and EPA assessments will take place.

Please note there is no formal qualification for the on-programme element of this qualification, however the training specification on the website details the on-programme requirements for this standard.

In the meantime we advise centres to continue to offer the SASE framework until further notice as this remains open now due to these delays in the new apprenticeship standard.

### **Level 2 Carpentry and Joinery 9078-12**

We are approved as an EPAO to offer this standard.

The assessment plan for this standard is approved and we are currently developing all the EPA assessment material. Registrations are now open for this EPA (Opened Mid August 2019). EPA packs and assessment material will be available in mid September. EPA reservations and bookings are planned to be available November 2019. For more details, please refer to the **webpage**.

In the meantime, centres can continue with the on-programme element, which is the 6571 Level 2 NVQ Diploma in Wood Occupations (Construction), in preparation to going onto the End-point Assessment.

### **Advanced Carpentry and Joinery 9079-12**

We have applied to be approved as an EPAO for this standard and are awaiting confirmation of approval, ready for delivery for this EPA in Autumn 2019. Registrations are due to open mid September 2019 (as soon as we receive confirmation that we are an approved EPAO for this standard). EPA packs and assessment material will be available mid September, and first assessments will be available in November 2019.

In the meantime, centres can continue with the on-programme element, which is the 6571 Level 3 NVQ Diploma in Wood Occupations (Construction), in preparation to going onto the End-point Assessment. There are two pathways for this- Site Carpentry (6571-27) and Architectural Joinery (6571-28).

## Plasterer 9086

We will be applying to be approved as an EPAO for this standard soon. Timescales will be communicated in future newsletters.

The assessment plan is currently undergoing amendments and we will inform you when the revised assessment plan is approved. There is an assessment plan currently on the IfA website which is showing as a final assessment plan, but this will be replaced later this summer once the new assessment plan is approved. Once we receive confirmation of this we will communicate detailed timescales for when registrations will be open and first EPA assessments will take place. For more details, please refer to the **webpage**:

Please note there is no formal qualification for the on-programme element of this qualification, however there will be a training specification on the website once the assessment plan is finalised that details the on-programme requirements for this standard.

## Painter and Decorator

We will be applying to be approved as an EPAO for this standard soon. Timescales will be communicated in future newsletters. Once we receive confirmation of this we will communicate detailed timescales for when registrations will be open and first EPA assessments will take place.

Please note there is no formal qualification for the on-programme element of this qualification, however there will be a training specification on the website once the assessment plan is finalised that details the on-programme requirements for this standard.

In the meantime we advise centres to continue to offer the SASE framework until further notice as this remains open now due to these delays in the new apprenticeship standard.

## **Wales Update- Skills for Wales – Construction and Building Services Engineering**

### **New qualifications – September 2021.**

From September 2021 City & Guilds/EAL will be the sole provider of a new suite of fundable Construction and Building Services Engineering qualifications in Wales.

Qualifications Wales is leading a process to streamline skills and raise standards through a review of the qualifications system across the construction and built environment sectors. The Qualifications Wales Building the Future report identified the need to rationalise hundreds of qualifications into a simplified qualification system that had clear progression routes and met the needs of employers and the economy of Wales.

In laying these foundations for the future Qualifications Wales has jointly appointed City & Guilds and EAL in a collaboration to deliver a suite of five new vocational Construction and Building Service Engineering qualifications at Level 2 and 3, including foundation, progression and apprenticeship qualifications, featuring clear progression routes for learners through the qualifications on to both employment and further study.
