### **Ready for Construction**

Our new `Ready for Construction` online course is now live. The Ready for Construction course is designed to allow learners to explore the construction sector. The course can be applied to any programme type from full time study programmes to traineeships and apprenticeships. The course also attracts funding across all provision types, including adult skills (AEB).

Below is an overview of the course and the benefits to learners.

- 3-4 hour digital course for learners of all ages to understand what it's like to work in the sector

What an exciting two months we have had supporting our centres and providers in Wales. Our Team of TAs including, Ian, David, Amelia and Jason have been delivering a series of CPD events focusing on the delivering and assessment of the Foundation, Core and Progression qualification. The events were very informative and included a role play of a guided discussion. This was well received by delegates who got to see our very own David Pye and Ian Roberts emerge into character to put on a fantastic performance, to support delegates awareness in good and bad practices of a guided discussion. In total the team have delivered 9 CPD events across Wales delivering to hundreds of attendees. We would like to thank each college who hosted the events and for allowing other colleges to attend, providing a warm welcome to all.

February and March also saw the team deliver two follow up webinars for centres in preparing to deliver the Foundation and Progression qualifications as well as launch of our Level 3 Qualification webinars. Our centre support continued with our TAs attending several employer events supporting our providers and their employers in the understanding of delivery and assessment of the Level 3 qualifications. We are now planning and preparing for our next round of support events which will including, preparing to deliver L3 qualifications and the Employer Confirmation Guide. ### **City & Guilds Foundation supports Bounce Back construction programme**

Through our City & Guilds Foundation, we're proud to be supporting Bounce Back with funding towards their new and innovative in-prison construction programme. Bounce Back are a charity and social enterprise focused on the training and employment of people in, and leaving prison.

In 2019, the Foundation established a £1m Big Idea Fund which committed funding towards programmes and initiatives that develop transformative approaches to support former offenders to develop the skills they need to find employment.

The programme that the Foundation is supporting with funding towards is a virtual reality headset that will train individuals with key construction skills including traffic marshalling, employability and gaining CSCS cards. Keltbray XR are also putting some funding towards the programme.

Like most Prison programmes, Covid has had an impact on us being able to start delivering the training because of strict lockdowns – but we are delighted that the training cohorts are expected to start in the Spring.

Speaking about the programme, **Polly Rowe, Programme & Engagement Manager from The City & Guilds Foundation** said: *'We are delighted to be supporting this innovative programme through the Foundation. When we created the Big Idea Fund we knew that we wanted the programmes we fund to identify new approaches to learning and offer a route in to stable employment. Bounce Back has some fantastic employer connections to support individuals through the gate when they are released – and we're confident that we'll really be able to demonstrate impact on the individuals on programme, the organisations they go on to work with & to wider society by ultimately reducing the risk of the individual reoffending.'*

Across City & Guilds we are managing the impact we're having as an organisation – and using our theory of change / impact framework, we will be tracking the progress of our funding over the coming months and years.

### **New Apprenticeship EPA Webinars coming in June this year**

These events focus on the Construction Apprenticeship Standards in Bricklayer, Carpenter/Joiner, Painting and Decorator and Plasterer. It will also briefly touch on the new Technicals and T levels.

Topics to be covered will include - Understanding the Standard and the associated Assessment Plan. Training Specifications and Apprenticeship Training Manuals (ATM). RPL: How this impacts the apprenticeship. 20% off the job training- what can be included. Functional skills reforms- impact on standards/mapping. Teaching and learning resources to support On-Programme (OP) delivery. Blended learning/ digital integration for teaching and learning. Understand how to prepare learners for gateway. What does EPA look like per Standard: Brick, Carpentry, Painting and Plastering. How to prepare learners for EPA - resources. Gateway checklists. Gateway process/sign off (preparation/process/procedures).

## **Technicals in Bricklaying, Carpentry and Joinery, Painting and Decorating and Plastering at level 2 and level 3**

On the 12 January 2022 a webinar took place to provide an overview of the 'Technicals' in the construction main trades: Brick, Carpentry, Painting and Plastering.

As you know the Government is driving Technicals implementation, particularly at level 2 and 3 i.e. QCF to RQF qualifications and T levels at level 3. Technicals are different as they have performance points and are assessed through a single knowledge test and practical assessment.

The webinar covered Technicals content and assessment requirements. Also, how C&Gs supports centres in delivery. The focus of the webinar is specifically on the synoptic and exam.

We are pleased to announce that the new NVQ qualifications below have now been approved for funding by the ESFA. Please go to FALA for the funding details [here](#).

- 60376879 *City & Guilds Level 2 NVQ in Insulation and Building Treatments (Construction)*
- 60376338 *City & Guilds Level 2 NVQ in Decorative Finishing and Industrial Painting Occupations (Construction)*
- 6037634X *City & Guilds Level 3 NVQ in Decorative Finishing - Painting and Decorating (Construction)*

The legacy NVQs below will have their funding removed as of the 10 April 2022, as they are now replaced with the above qualifications.



- 60332281 City & Guilds Level 2 NVQ Certificate in Insulation and Building Treatments (Construction)
- 60078649 City & Guilds Level 2 NVQ Diploma in Decorative Finishing and Industrial Painting Occupations (Construction)
- 60112359 City & Guilds Level 3 NVQ Diploma in Decorative Finishing - Painting and Decorating (Construction)

Centres must use the new NVQs for their funded provision from the 10 April 2022. We will be closing the legacy qualifications in due course.

We are still waiting to hear the outcome of our funding application for the 60376892 City & Guilds Level 3 NVQ in Insulation & Building Treatments, we will update you as soon as we have further information.

### **6574-21 to 28 Level 2 NVQ Diploma in Construction and Civil Engineering Operations (Construction)**

This qualification is currently undergoing an incremental change and a new version will be **available for delivery from August 2022**. Centres that currently offer this qualification will be given automatic approval to deliver the new version. The qualification number for this will be 6574-40 to 49. The title of the new qualification will be slightly different as the industry no longer want to use 'Diploma' in the title, therefore it will just be a Level 2 NVQ in Construction and Civil Engineering Operations.

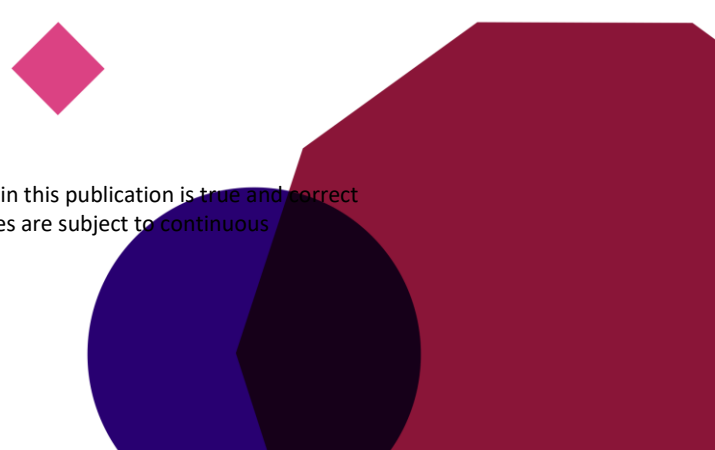
