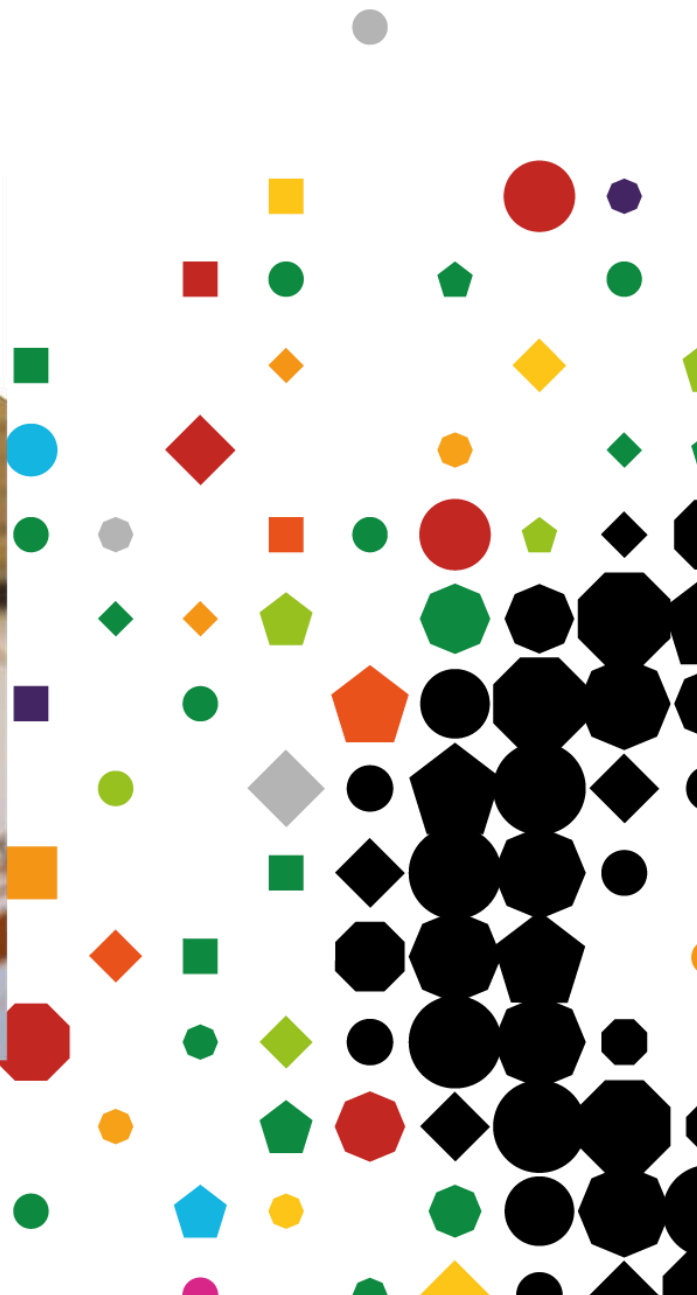

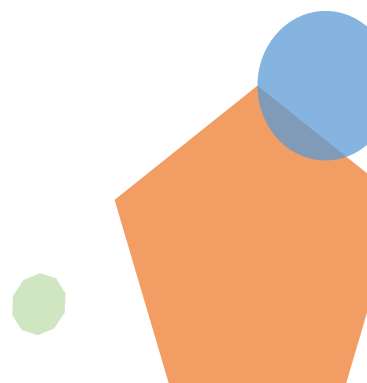

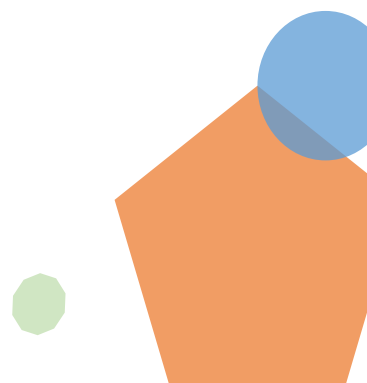
## 7100/7120 synoptics 2022/2023

### **Notification of synoptic practical assessments for 2022/2023**

#### **Professional Cookery (7100) & Patisserie and Confectionery (7120)**

Each year in May, City & Guilds announce which combination of synoptic tests candidates must be assessed against in the following academic year for the above qualifications. Accordingly, please be advised of the choice of assessments on offer for 7100 and 7120 for the 2022/2023 academic year:

- For candidates registered on 7100 qualifications for 2022/23, we can now confirm that they should be assessed on synoptic assessments **C1 & C4**.
- For candidates registered on 7120 qualifications for 2022/23, we can now confirm that they should be assessed on synoptic assessment **C4**.

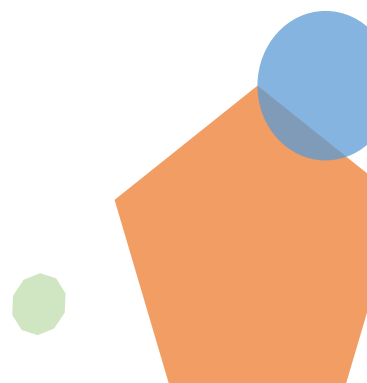

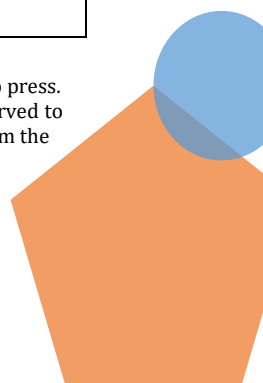
