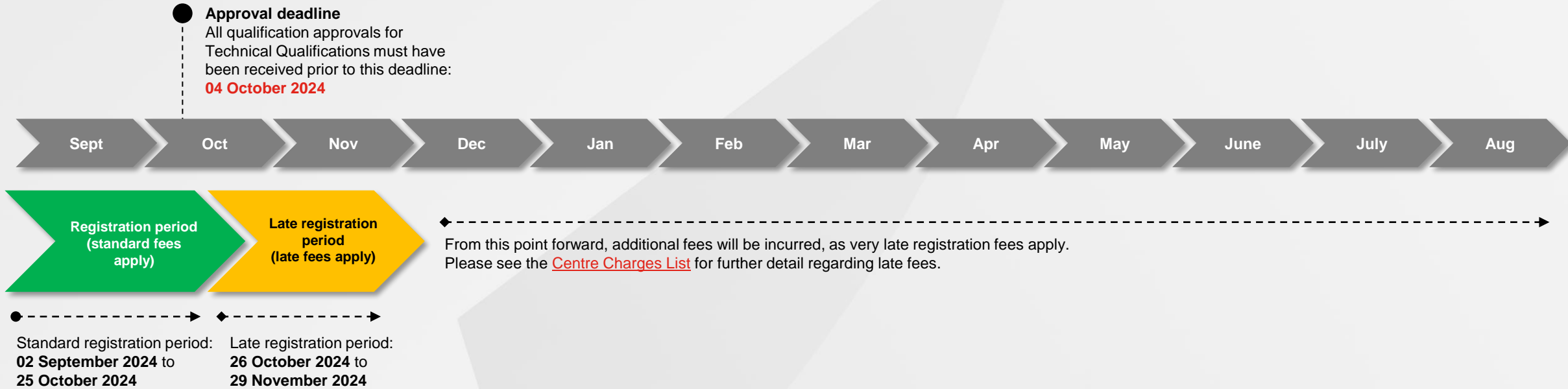
Registration and entry windows

Registration windows



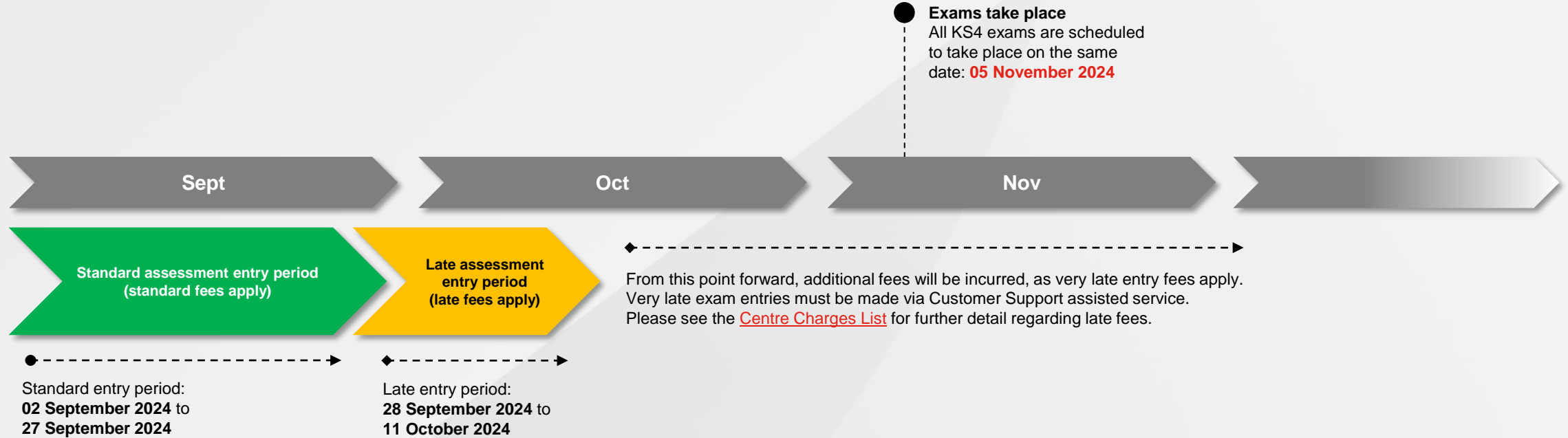
Centres are encouraged to register learners at the start of the academic year in which delivery begins, and before the standard registration cut-off date to avoid incurring late registration fees. This applies even in cases where the centre does not intend to enter learners onto assessments until the second year of delivery.

Technical Qualifications will incur late and very late fees for any registrations made outside of the standard registration period per academic session, as outlined below:

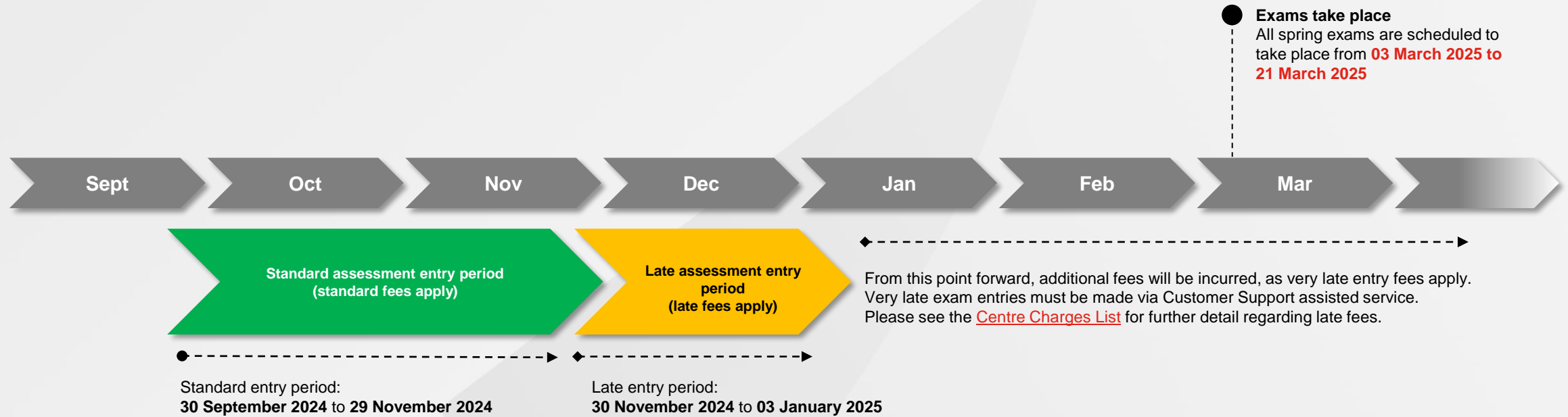

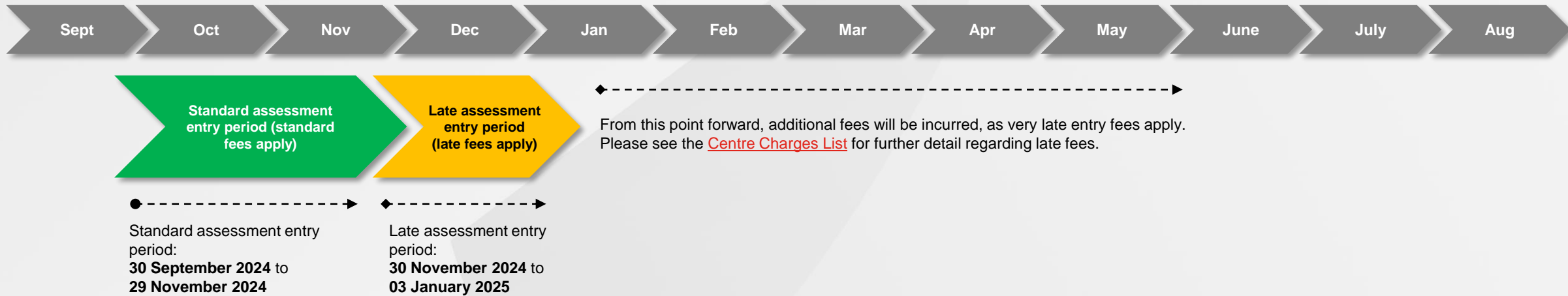
Assessment entry period

Synoptic, centre assessed, and employer involvement



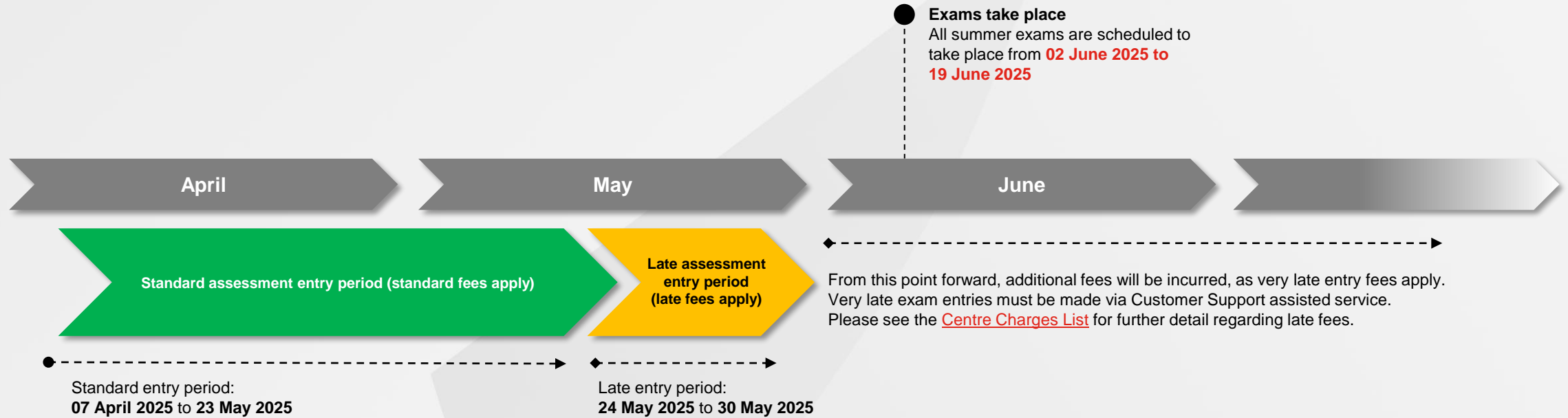
At the start of each academic year, centres must enter learners onto the assessments which they intend to deliver within that academic year.

Assessment delivery and submission deadlines

Synoptic assignments

09 September 2024 to 25 October 2024:

Centres may access synoptic assignments (password protected from our website), to review the content.

Points of clarification, or feedback regarding the assignment, can be submitted to City & Guilds to ensure centres are able to fully understand the content and delivery of the synoptic assignment.

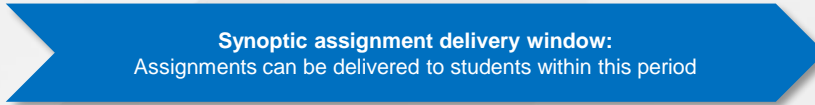
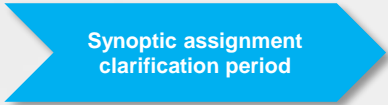
After taking on board your feedback and making some final adjustments, the finalised version of the synoptic assignments will be published by **02 December 2024**.

06 January 2025 to 16 May 2025:

Centres may schedule the synoptic assessment within this period (however, please remember that 16 May is the final date for providing evidence for moderation, so allow time for marking and quality assurance and to avoid incurring late submission fees).

Please see specific details of permitted timings of the assessment within each synoptic assignment pack.

Some synoptic assessments are subject to a moderation visit.



Submission deadline: 16 May



02 December 2024
Finalised versions of synoptic assignment material is published.

No further changes are made to the material beyond this point.

The deadline for submission of all synoptic assignment marks and evidence is **Friday 16 May 2025**.

Any late submissions from this point forward are subject to additional administrative fees, as published within the [Centre Charges List](#).

Centre assessed components

After Easter, the Quality team will notify centres of which centre assessed components have been selected as the 'defined sample'. This is the student evidence which must be uploaded to us for sampling.

The grades and evidence for all candidates within the 'defined sample' must be submitted via the Moderation Portal by **Tuesday 03 June 2025**.

For all other centre-assessed components which are not part of this defined sample (including work experience units and Employer Involvement for Key Stage 5), the deadline submission date is **Friday 13 June 2025**.

"Defined sample" submission deadline: 03 June
Remaining centre assessed component and EI submission deadline: 13 June

Centre assessed components can be taught and assessed at any point throughout the academic year



Any submissions of grades and evidence after these published deadlines are subject to additional administrative fees.
