
This report provides general commentary on candidate performance in both the synoptic assignment and theory exam. It highlights common themes in relation to the technical aspects explored within the assessment, giving areas of strengths and weakness demonstrated by the cohort of candidates who sat assessments in the 2024 academic year. It will explain aspects which caused difficulty and potentially why the difficulties arose.



## **Chief Examiner Commentary**

#### 0170-505 Level 2 Technical Award in Land Based Studies - Theory exam

#### Series 1 - June 2024

Overall, responses from the candidates were of a very good standard, leading to a good pass rate.

There were examples of good detail given for a fairly high percentage of the AO2 explain /describe type questions with good use of technical vocabulary. Where candidates did not achieve highly in this type of question, the answer tended to give named examples with little description to go with it.

#### Overall, candidates showed strength in:

- Common Pests (Unit 202)
- Safe handling of animals PPE (Unit 202)
- Land use Energy Production (Unit 201)
- Structures in plant cells (Unit 202)
- Range of technology animal health and welfare (unit 203)

#### Candidates require further support in:

- Enclosure of land (Unit 201)
- Responsibilities of non-government organisations (RSPCA) (Unit 201)
- Nutritional requirements of plants (Unit 202)

Candidates demonstrated a good recall of knowledge across a number of topics, gaining marks in areas such as PPE for safe handling of animals and identifying common pests. Candidates tended to score very well on the AO1 animal-related questions but demonstrated a weakness in the enclosure of land.

The AO2 questions were on the whole very well answered with some high level of detail for the more general land-based questions eg PPE for safe handling of animals and describing methods of energy production. Some excellent technical language was seen from higher-scoring candidates.

#### **Extended Response Question (ERQ)**

Overall, this question was very well answered with most candidates exploring a range of different impacts when land is used for leisure in the countryside. There were some excellent well-planned answers to this question, exploring a range of positive and negative impacts. These included pollution from litter and increased traffic, the effect on wildlife and biodiversity, noise and light pollution, and opportunities for employment. The answers that gained the most marks also explored environmental solutions to some of the problems like providing park-and-ride schemes, and discussed the positive impact on mental health. The poorer answers discussed only one or two impacts and tended to have repetition. This question was generally well planned with candidates picking out keywords and understanding command words.



## **Principal Moderator Commentary**

Assessment component: 0170-005

Series: Summer 2024

The synoptic assignment contained a wide range of tasks which allowed centres to give candidates every opportunity to achieve their full potential.

Candidates have shown a wide range of abilities throughout all Assessment Outcomes (AOs). Overall, a good and in some cases an excellent attempt has been made on the written elements of the synoptic assignment with a wide range of quality within the work shown. Candidates must be congratulated on the very realistic approach that has been made to the scenario with some very realistic ideas put forward on Task 3.

Practical tasks were completed to a good standard with a very varied range of animals used. Risk assessments showed improvement. Health checks were completed well but feeding logs lacked some detail eg what was fed, how much, when, and how. This should be fully detailed within tutor reports.

In some cases, details around legislation were lacking. Centres are asked to highlight this as a requirement for their candidates.

- Centres are asked to ensure that all documents are uploaded in a timely fashion to allow for the moderation process to take place
- Centres are asked to include areas for improvement on the Candidate Record Form (CRF) unless the mark awarded is in the excellent band.
- Centres are asked to annotate on candidates work incorrect statements and the quality of the work, e.g. areas which are good or lacking detail
