OVERVIEW

- What does this qualification cover?

This qualification covers a very wide range of areas related to the skills and knowledge required for working in the Environmental Conservation industry.

All learners will cover the mandatory core unit of:

Promote, monitor, and maintain health, safety and security of the workplace

You can then take optional units that are relevant to your chosen pathway:

- Environmental Conservation
- Access and Recreation
- Flood Risk Management

The choice of optional units will reflect the work environment that you are in, and the type of role that you are carrying out. There are a wide range of optional units, but examples include:

Co-ordinate and oversee habitat management work

Present and promote the characteristics and values of the organisation

Consult and work with the local community

Manage environmental emergencies and incidents

Advise on environmental information and developments

Raise awareness of the risk, potential impact and arrangements in place for emergencies.

This is a Framework qualification.

- Who could take this qualification? OR who is this qualification designed for?

This qualification is part of the Apprenticeship in Environmental Conservation, or it may be taken as a stand alone qualification.

It is a work-related, competence-based qualification, and is designed for someone in work or who wishes to progress into work. It reflects the skills and knowledge needed to do a job effectively, and shows that you are competent in the area of work the qualification represents. The qualification may allow you to combine working for a Conservation

business, such as a Wildlife Trust or Nature Reserve and typically involves you attending one day a week at College or with a Training Provider.

There are no specific prior achievements required to take this qualification, but a Level 2 qualification in Environmental Conservation or other Land-based related subjects could be an advantage. You need to be 16 years old or over to take this qualification.

WHAT COULD THIS QUALIFICATION LEAD TO?

This qualification could lead to jobs such as:

- Access/recreation Manager
- Ecologist
- Environmental Management Officer
- Senior Ranger
- Education Officer
- Senior Estate Worker

You could progress to other qualifications at Level 3 such as:

Level 3 Certificate in Countryside Management
Level 3 Subsidiary Diploma in Countryside Management
Level 3 90 Credit Diploma in Countryside Management
Level 3 Diploma in Countryside Management
Level 3 Extended Diploma in Countryside Management
