OVERVIEW

- What does this qualification cover?

This qualification covers a very wide range of areas related to the skills and knowledge required for working in the Trees and Timber industry.

All learners will cover the mandatory core unit of:

Promote, monitor, and maintain health, safety and security of the workplace

You can then take optional units that are relevant to your chosen pathway:

- Arboriculture
- General Woodland and Forestry Treework
- Coppicing and Greenwood Trades

The choice of optional units will reflect the work environment that you are in, and the type of role that you are carrying out. There are a wide range of optional units, but examples include Access a tree using a rope and harness, Plan and carry out plant protection by chemical means, Carry out site surveys and communicate findings, Carry out aerial cutting of trees with the assistance of a crane, Forecast production of forest and woodland products or Monitor and evaluate the effectiveness of habitat management work.

This is a Framework qualification.

- Who could take this qualification? OR who is this qualification designed for?

This qualification is part of the Apprenticeship in Trees and Timber, or it may be taken as a stand alone qualification.

It is a work-related, competence-based qualification, and is designed for someone in work or who wishes to progress into work. It reflects the skills and knowledge needed to do a job effectively, and shows that you are competent in the area of work the qualification represents. The qualification may allow you to combine working for a Forestry or Arboricultural business, such as a Forestry Contractor or Arboretum and typically involves you attending one day a week at College or with a Training Provider.

There are no specific prior achievements required to take this qualification, but a Level 2 qualification in Trees and Timber or other Land-based related subjects could be an advantage. You need to be 16 years old or over to take this qualification.

WHAT COULD THIS QUALIFICATION LEAD TO?

This qualification could lead to jobs such as:

- Assistant Head Forester
- Contractor (Harvesting and/or Establishment)
- Social Forester
- Woodland Manager
- Team Leader/Supervisor

You could progress to other qualifications at Level 3 such as:

Level 3 Certificate in Forestry and Arboriculture
Level 3 Subsidiary Diploma in Forestry and Arboriculture
Level 3 90 Credit Diploma in Forestry and Arboriculture
Level 3 Diploma in Forestry and Arboriculture
Level 3 Extended Diploma in Forestry and Arboriculture

You can take the Diploma as a stand alone qualification or as part of an Apprenticeship.
