## New Modern Apprenticeship Framework for Light Vehicle and Heavy Vehicle

In order to allow for a smooth transition from current Modern Apprenticeship Framework to the new one, the current Light Vehicle and Heavy Vehicle qualifications have been extended till **30 November 2016**.

## Approval process for the new Light Vehicle and Heavy Vehicle qualifications

Centres approved to offer the current **SVQs in Maintenance and Repair** (4310-12, -34 in light vehicle and 4310-22, -23 in the heavy vehicle) may apply for approval for these new qualifications using the fast track approval form available from the City & Guilds' website.

It is important that centres inform us via the fast track form whether they intend to deliver the new optional units for hybrids and electric vehicles, as this will inform the approval process.

Fast track approval is available for 12 months from the launch of the qualification. After this time, the qualification is subject to the standard Qualification Approval Process. It is the centre's responsibility to check that fast track approval is still current at the time of application'.

In regards to the **Diplomas in Maintenance and Repair** (4390-12, -13 for light vehicle and 4390-22, -23 for heavy vehicle), they are almost identical so we would provide centres with automatic approval.
