-  Nail Technician


City & Guilds are continuing to work with the Steering group, the Assessment plan has now been resubmitted to the IFA.

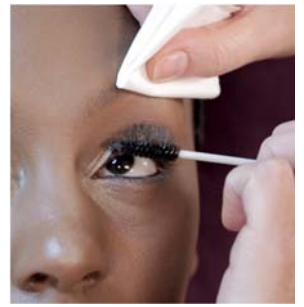

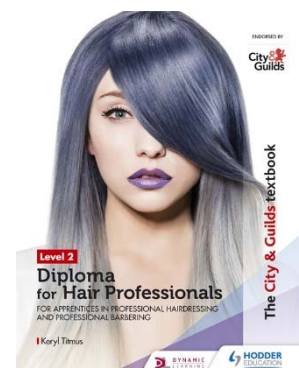
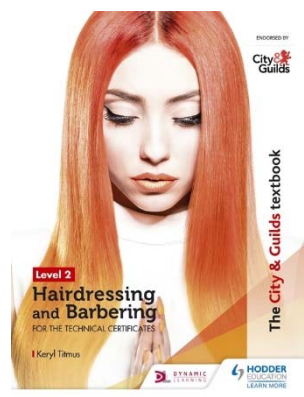
